TRMC MEMBERSHIP AGREEMENT - TERMS AND CONDITIONS

The following are the current terms from the TRMC membership form (I have added in some amendments in red/struck out for consideration):

- 2. I hereby agree that by signing the Agreement, I am authorised to enter into a rotational membership with TRMC on behalf of my company, recognising TRMC financial year is 1st July to 30th June of each year.
